BOOTH SPACE - 10x10 maximum

Broad Street: Set up at curb in street
Pine/Commercial Streets: Set up on sidewalk extending into street

SET-UP TIME

5 - 6 pm (or by police permission)
Early set-up is prohibited

REQUIREMENTS

Vendors must submit photos of all work to be sold and one photo of the booth.
Preference will be given to original handcrafted items. Items not pictured may not be sold

CANCELLATIONS

Refunds given prior to July 1 minus a \$25 processing fee
No refunds after July 1

PROHIBITIONS

Vans, Booths mounted on wheels
Electricity: Vendors may not access building outlets nor request power from merchants. Quiet generators are permissible

APPLICATION PROCEDURES

- 1) 5 photos of your work and 1 of your booth. Please have your name and address on them
- 2) A **CHECK** for **\$150** payable to Nevada City Chamber of Commerce

- 3) A self-addressed stamped envelope
- 4) Your application
- 5) Copy of your CA Resale Permit*
